RACQ promotes gender equality through a broad range of formal and informal policies which are available to all employees, including recruitment and selection, performance and career planning, secondments, higher duties, flexible work opportunities and diversity and inclusion.

All decisions regarding hiring, transfers, promotions or learning and development opportunities are based on the principles of merit.

RACQ provides a training program for new managers with the aim of equipping leaders with the necessary skills and knowledge to undertake recruitment and selection, performance reviews, career planning discussions and counselling and discipline processes.

RACQ is committed to growing our female talent and is proud to offer a Female Mentoring Programme (FMP). The FMP has facilitated the successful career enhancement of many of the organisation's female leaders. In fact, the FMP has seen a remarkable return on investment with over 45% of attendees receiving promotions within the organisation post participation. This program is designed to encourage female managers within RACQ and is an opportunity for self-development, with support from their senior management. It is also an opportunity for our female managers to network with each other with the aim of providing a supportive climate in which informal mentoring relationships can be formed.

RACQ conducts an annual talent management and succession planning process in which we identify High Potential (Hi-Po) employees. 23 of the 38 HiPo's identified in 2016 are female. During 2016, four out of six Hi-Po's promoted were female.
